RULES AND REGULATIONS

Updated on January 2, 2025 - Provisional Version

The Tigotà Kids Marathon, organized by BOLOGNA SPORT MARATHON S.S.D.A R.L. in collaboration with CSI (Centro Sportivo Italiano) – Bologna Committee, is a recreational walking event for children aged 4 to 10 years. This is a non-competitive, free-paced sports event with no individual rankings, classified as "Recreational activity as defined in Regional Council Resolutions n. 775/2004 and n. 9/2005 and subsequent amendments," and therefore does not require a competitive medical certificate. It is conducted in compliance with CSI sports regulations.

1. PREAMBLE

Participants and accompanying adults are encouraged to stay updated on these guidelines, which will be published on www.bolognamarathon.run.

INDIVIDUAL PARTICIPANTS: Registration is subject to completion on the website <u>www.bolognamarathon.run</u> or at the registration points indicated by the organizers.

2. PRACTICAL INFORMATION

The Tigotà Kids Marathon is a recreational running event on a course of 420 meters and 195 centimeters. The course will be marked with signs indicating the running direction, and it will be supervised by staff.

Start time: The event will start near the finish area of the Termal Bologna Marathon in Piazza Maggiore at 11:00 a.m. on Saturday, March 1, 2025. Please note that the start time and location may change due to technical or organizational requirements.

Parents and accompanying adults of the participating children will be allowed access to the area adjacent to the course, but not inside it, in order to provide support and assistance to the young participants.

Assistance: Assistance will be provided by the organization from the start until the last registered participant finishes.







3. REGISTRATION

Participation is open to all children aged 4 to 10, with a **maximum of 500 participants**, divided into two groups based on age.

Registration fees:

Children aged 4-6 years: €5 Children aged 7-10 years: €5

Important: The registration form, as it involves a minor, must be signed by a legal guardian.

The registration fee includes:

- T-shirt
- Race bib
- Welcome pack provided by Tigotà
- Assistance during the event
- Medal upon finishing

Registration options:

- Online via the website: www.bolognamarathon.run until February 26, 2025.
- At Tigotà stores in Bologna until February 26, 2025 (see map).
- Subject to bib availability, at the Race Office at Palazzo d'Accursio in Piazza Maggiore, Bologna, on Friday, February 28, 2025, from 3:30 p.m. to 7:00 p.m.

The organization reserves the right to close registrations early or accept late registrations at its sole discretion.

4. WELCOME KIT PICKUP

The welcome packs must be collected in person at the **Termal Bologna Marathon Expo in Piazza Maggiore** on:

- Friday, February 28, 2025, from 3:30 p.m. to 7:00 p.m.
- **Saturday, March 1, 2025**, from 10:00 a.m. to 11:00 a.m.

A legal guardian must present valid identification to collect the pack.

5. CANCELLATION OF THE EVENT

If the Tigotà Kids Marathon is canceled, postponed, or otherwise not held due to reasons beyond the control of the organization, including the revocation of permits by public authorities for any reason, no compensation or reimbursement of expenses incurred will be provided. The registration will be valid for the next edition of the event.







6. MANCATA PARTECIPAZIONE

The registration fee is non-refundable. In case of inability to participate, it is possible, no later than **February 13, 2025**, to:

- Request a transfer of the registration fee to the 2026 edition (no further postponements allowed).
- Transfer the registration to another person, subject to approval by the organizers. The new
 participant must complete a new registration form, including all personal information, and accept
 the rules entirely.

7. RESPONSIBILITY

By registering for the Tigotà Kids Marathon, the legal guardian of the participant declares: to have read and fully accepted these rules; that the minor is physically fit to participate in the event; and assumes all risks arising from participation, including falls, contact with other participants and/or spectators, vehicles, or other objects, and weather conditions (hot/cold, rain, or humidity).

8. PRIVACY AND IMAGE RIGHTS

Regarding the processing of personal data, the legal guardian of the participant declares to have read the privacy notice under Article 13 of EU Regulation 679/2016 ("GDPR"), available via the link provided on the online registration form and on the website www.bolognamarathon.run/privacy-policy/. Providing personal data is optional; however, failure to do so will prevent registration.

The data will be complete, updated, and legible for insurance purposes. The data may also be shared with third parties offering services related to the event, such as timing services, results announcements, and photography or videography services. These third parties will act as "external data processors" under Article 28 of the GDPR or, in some cases, as "data controllers" under Article 14 of the GDPR.

The event will be recorded, and images, photos, videos, and audio recordings may be communicated, published, or disseminated in any form. The legal guardian expressly authorizes the organization and its professional and commercial partners to acquire the free right to use such images for promotional or advertising purposes, on any medium, for the maximum period allowed by current laws.

9. FINAL PROVISIONS

The organizers reserve the right to modify these rules at any time to ensure better event organization and/or due to force majeure. Any changes to schedules, services, or locations will be communicated to participants via the event's official website www.bolognamarathon.run.
